AN ORDINANCE TO AMEND CHAPTER 5 OF THE CITY CODE REGARDING THE HOURS OF OPERATION ON SUNDAYS

FOR SELLERS OF INTOXICATING LIQUORS.

**WHEREAS**, the City Council has enacted the provisions of Chapter 5 of the City

Code setting forth business code requirements and the specific provisions in the Articles and

Sections of that Chapter; and

WHEREAS, on June 17, 2004, the City Council passed Substitute No. 2 to

Ordinance 04-009, which amended the provisions of Chapter 5 of the City Code by limiting the

hours of operation for liquor stores that operate on Sundays to a maximum of four hours between

12:00 p.m. and 4:00 p.m.; and

WHEREAS, on December 21, 2006, the City Council passed Ordinance No. 06-

084, which amended the provisions of Chapter 5 of the City Code by extending the permissible

hours of operation for liquor stores that operate on Sundays, whenever a Sunday falls on

Christmas Eve or New Year's Eve, to a maximum of eight hours between 12:00 p.m. and 8:00

p.m.; and

WHEREAS, the 148<sup>th</sup> Session of the Delaware General Assembly passed House

Bill 156, which was signed by the Governor on June 30, 2015; and

WHEREAS, House Bill 156 continued the process of updating the Liquor

Control Act to make it more consumer-friendly by permitting liquor stores to operate on Sundays

between the hours of 12:00 p.m. and 8:00 p.m. during the months of January through September

and between the hours of 10:00 a.m. and 8:00 p.m. during the months of October through

December; and

WHEREAS, the City Council deems it necessary and proper to amend the general business provisions of the City Code to limit the hours of operation of liquor stores that operate on Sundays between 12:00 p.m. and 5:00 p.m. during the months of January through September and between 10:00 a.m and 5:00 p.m. on Sundays during the months of October through December.

## NOW, THEREFORE, THE COUNCIL OF THE CITYOF WILMINGTON HEREBY ORDAINS:

**SECTION 1.** Chapter 5 of the City Code is hereby amended by deleting the stricken language in brackets and by adding the underlined language to read as follows:

## Sec. 5-1 Businesses operating on Sundays, which sell spirits, wine and beer.

A holder of a license for the sale of spirits, wines or beer in a store may, at the licensee's discretion, sell spirits, wine or beer on Sundays between the hours of 12:00 p.m. and [4]5:00 p.m. during the months of January through September and between 10:00 a.m. and 5:00 p.m. during the months of October through December. In the event that Christmas Eve and New Year's Eve are on a Sunday, then the sale of spirits, wine or beer shall be permitted from 1[2]0:00 [p]a.m. to 8:00 p.m. Any holder of a license for the sale of spirits, wine or beer in a store that chooses to conduct business on Sundays may, at his or her discretion remain closed for business on one other day of the week without notice to, or prior approval from, the state alcoholic beverage commissioner, provided that the store's daily hours are conspicuously posted on the store's front window or door.

**SECTION 2.** Effective Date: This Ordinance shall become effective immediately upon its date of passage by City Council and approval by the Mayor.
