President Gregory: Mr. Darius Brown.

*Mr. Darius Brown: Thank you Mr. President. I'd ask that I be marked

present.

Mrs. Seijo: So noted.

Mr. Darius Brown: Mr. President, I have a Resolution to present.

Mr. Darius Brown presented Resolution No. 14-026 (Agenda #3947) as

follows:

WHEREAS, the Promise Zone Initiative is a federal program with a stated objective of revitalizing high poverty communities across the country by creating jobs, increasing economic activity, improving educational opportunities, leveraging private investment, and reducing violent crime; and

WHEREAS, the Promise Zone designation enables the federal government to partner with local leaders who are addressing multiple community

revitalization challenges in a collaborative way and who have demonstrated a commitment to results; and

WHEREAS, the federal government intends to approve five Promise Zone designations in the United States each year for the next four years, each lasting for a period of ten years from the date of the designation; and

WHEREAS, each designated Promise Zone will be asked to identify a set of outcomes they will pursue to revive their communities, to develop a strategy supporting those outcomes, and to realign resources accordingly; and

WHEREAS, the City of Wilmington qualifies and is eligible to apply and compete for a Promise Zone designation; and

WHEREAS, the Promise Zone designation commits federal staff to be stationed in each designated community, and will further provide technical assistance and preferential access to certain existing funding streams; and

WHEREAS, businesses which invest in or hire residents of Promise Zones will also be eligible to receive tax incentives for these activities, if the tax incentives are enacted by Congress.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the City Council hereby encourages and supports the Administration to take the necessary steps required to apply and compete for the City of Wilmington to be designated as a Promise Zone Region.

Mr. Darius Brown: Yes Mr. President. The Promise Zone is the second interation of an initiative by the White House and their initiative of urban affairs, Office of Urban Affairs. They began with a "Strong Cities Strong Communities" initiative and through that they helped leverage federal resources to cities around the country. They have recently solicited a NOFA, Notice of Funding for cities and suburbs in tribal areas to apply for this designation and so this Resolution is Council supporting the Administration in making its admission for this designation for the City of Wilmington.

President Gregory: Councilwoman Shabazz.

Ms. Shabazz: Thank you Mr. President. I really commend Councilman Brown for this Resolution because if we get designated, there's a lot of initiatives and projects that's on the table now that we can really benefit and get them off the ground. So, I solely support this and ask that be added as co-sponsor.

President Gregory: So noted. Councilwoman Dorsey Walker.

Ms. Dorsey Walker: Thank you Mr. President. I too want to commend Councilman Brown for a job well done bringing this to the City of Wilmington and I'd also like to be added as co-sponsor.

Mr. Darius Brown: Mr. President, I have a Resolution to present.

Mr. Darius Brown presented <u>Resolution No. 14-027</u> (Agenda #3948) as follows:

WHEREAS, pursuant to <u>Wilm</u>. <u>C</u>. (Charter) § 1-101, the City of Wilmington (the "City") may acquire, hold, manage, and dispose of property on such terms it deems appropriate for any municipal purpose; and

WHEREAS, the Department of Real Estate and Housing of the City (the "Department") is the legal owner of the property located at 2110 North Jessup Street, Wilmington, Delaware, being Tax Parcel Number 26-029.202-00 (the "Property"); and

WHEREAS, on February 2, 2012, Wilmington City Council ("Council") did declare the Property as surplus pursuant to Resolution No. 12-014; and

WHEREAS, a request for proposals was issued by the Department, in accordance with the procedures set forth in <u>Wilm. C.</u> § 2-622 through § 2-624, and the request for proposals was advertised in the News Journal on April 24, 2014 and on April 28, 2014 being due to the Department by May 19, 2014; and

WHEREAS, a proposal in the amount of \$8,000.00 was received from Mr. Edwin Mitchell, and he proposes to renovate the Property for homeownership; and

WHEREAS, Council, upon the recommendation of the Department, hereby authorizes the City to dispose of the Property to Mr. Edwin Mitchell.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that Council hereby authorizes and approves the disposition of the Property from the City to Mr. Edwin Mitchell.

BE IT FURTHER RESOLVED that Council authorizes the Mayor or his designee to execute any and all documents necessary to effectuate the transfer of the Property, including any and all undertakings and assurances heretofore.

Mr. Darius Brown: Yes Mr. President, the City's Department of Real Estate and Housing is requesting the disposal of 2110 North Jessup Street to a property owner Mr. Edwin Mitchell at the cost of \$8,000. This is an effort to help sustain that 2100 block of Jessup Street in the 3rd Council District. Mr. Darius Brown presented <u>Resolution No. 14-028</u> (Agenda #3949) as follows:

WHEREAS, transportation is fundamental to the vitality and strength of Wilmington and the State of Delaware, its cities and neighborhoods, and its economy and public safety; and

WHEREAS, the transportation infrastructure is underfunded and in many ways inadequate to facilitate economic growth, business distribution needs, downtown revitalization, and future population trends; and

WHEREAS, bridge improvements and maintenance have gone neglected like that of I-495, due to inadequate funding; and

WHEREAS, public transportation continues to gain riders yet suffers from a shortfall in funding; and

WHEREAS, public transportation and other alternatives help alleviate traffic, minimize pollution and accommodate under served and environmentally friendly residents; and

WHEREAS, road, highway, transit and bridge improvements have traditionally enjoyed bipartisan support in Congress; and

WHEREAS, federal transportation programs expire on September 30, 2014 and federal funding may run out before that time; and

WHEREAS, the US Department of Transportation has warned states that funding for projects will cease; and

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that in order to improve the economy and quality of life in Wilmington, and to better ensure the safety of our citizens, this Council does hereby support efforts to pass a bipartisan, long term funding program for much needed transportation projects throughout our City.

Mr. Darius Brown: Yes Mr. President, this Resolution is a Resolution at the request of the National League of Cities, which is an organization that the City of Wilmington is a part of asking municipalities to support the federal funding of the Federal Highway Trust Fund and developing Resolutions to request that their Congressional Delegation support funding of infrastructure. I think we currently understand the importance of it with the 495 issue and then many other infrastructure issues that we as Council people face as small as potholes and as large as road construction.

President Gregory: Councilwoman Shabazz.

Mr. Michael Brown: Nothing else Mr. President, thank you.

President Gregory: Mr. Wright.

Mr. Wright: Yes, I have a Resolution to present.

Mr. Wright presented Resolution No. 14-029 (Agenda #3958) as follows:

WHEREAS, Congress originally established the Basic Educational Opportunity Grant Program in the 1972 Reauthorization of the Higher Education Act, later renamed the Pell Grant program in 1980 in honor of Senator Clairborne Pell; and WHEREAS, Senator Mary Landrieu has introduced Bill S.2374, known as the "Middle Class Chance Act" which increases the maximum amount of Pell Grants awarded to eligible students and extends the number semesters students can attend an institution of higher education from 12 to 15 semesters; and

WHEREAS, Pell Grants are the nation's largest source for funding need based education and provide federal grant aid directly to financially needy undergraduate students to pay for the cost of attendance at any eligible institution of higher education; and

WHEREAS, since 1982, the cost of attending college has increased 439%, more than four times the rate of inflation; and

WHEREAS, Pell Grants ensure that qualified students have access to obtaining a college degree, and are the primary form of financial aid used by most students; and

WHEREAS, according to the American Association of State Colleges and Universities, more than \$33 billion in scholarships were awarded under the Pell Grant program to nearly 9.7 million students in 2011 to 2012, almost 80% of whom come from families living under the national average annual income; and

WHEREAS, investing in Pell Grants more than pays for the cost of the program by compensating the nation with an educated work force, decreases the burden on social services, increases tax revenues and economic growth, which benefits not only the country as a whole, but also the State and the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the City Council wholeheartedly endorses Senator Landrieu's bill to improve college affordability by increasing the maximum amount awarded to eligible students under the Pell Grant program, as well as extending the number of semesters students can attend institutions of higher education, and urges Congress to pass Bill S. 2374 allowing students to achieve the 'American Dream' of earning a college degree.

Mr. Wright: Yes Mr. President. This is U.S. Senate Bill 2374 I'm in support of it. This Resolution, which is known as "Middle Class Chance Act", it increases the maximum semesters from 12 to 15 in which a person can receive a Pell Grant subsidies if you will for eligible students. It also, the Pell Grant since 1982, excuse me, the actual - - since 1982, the cost for attending college has increased four times the rate of inflation. So, the Pell Grants' helped more than 33 billion scholarships have been awarded and about 80% of those who received these grants come from a family that's living under the national average annual income. So, therefore, I seek support.

President Gregory: Mr. Darius Brown.

Mr. Darius Brown: Thank you Mr. President, I ask that I be added as a co-sponsor.

President Gregory: So noted. Ms. Hanifa Shabazz.

Ms. Shabazz: Same, co-sponsor please.

President Gregory: Likewise, so noted. Clerk, call the roll.
