WHEREAS, a proposal in the amount of \$800.00 was received from Mr. David Hammond, the adjoining neighbor to the Property and the legal owner of 632 Townsend Street, and he proposes to use the Property as a side yard; and

**WHEREAS,** Council, upon the recommendation of the Department, hereby authorizes the City to dispose of the Property to Mr. David Hammond.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that Council hereby authorizes and approves the disposition of the Property from the City to Mr. David Hammond.

It was two offers offered for it but because he's a property owner and plans to use it for a side yard and has been maintaining it, he — the community supported it and I ask that Council also support this Resolution to dispose this property.

President Gregory: Clerk will call the roll.

Upon a motion of Ms. Shabazz, seconded by Mr. Williams, the above aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, D. Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, M. Brown, Cabrera and Wright, and Council President Gregory. Total, twelve. Nays, none. Absent, Council Member Walsh. Total, one.

President Gregory: Declare it adopted. Ms. Shabazz.

Ms. Shabazz: Mr. President, I have an Ordinance to present and call for the first and second reading.

Ms. Shabazz presented and called for the first and second reading Ordinance No. 14-024 (Agenda #3936) entitled:

# AN ORDINANCE TO ENACT CERTAIN TRAFFIC/ PARKING REGULATIONS

This Ordinance was given two separate readings by title only and upon a motion of Ms. Shabazz, seconded by Mr. Williams, was received, recorded and referred to the Public Works & Transportation Committee. Motion prevailed.

President Gregory: Ms. Shabazz.

Ms. Shabazz: Mr. President, I have a Resolution to present.

Ms. Shabazz presented <u>Resolution No. 14-021</u> (Agenda #3937) as follows:

WHEREAS, on April 14, 2014, over 300 teenaged girls in Chibok, Nigeria, were kidnapped by a militant Islamic terrorist group known as Boko Haram; and WHEREAS, the girls were kidnapped from a local government secondary school that teaches math and science because they were receiving a non-Islamic or Western education; and

WHEREAS, in carrying out the kidnapping, Boko Haram conducted a five-hour assault on the village; and

WHEREAS, in attempting to flee their kidnappers, at least two children died; and

WHEREAS, media reports indicate that over 276 children still remain unaccounted for and that additional kidnappings by Boko Haram may be occurring in the country; and

WHEREAS, reports indicate that the children may have been forced into sexual slavery and trafficked into neighboring towns and countries; and

WHEREAS, millions around the world have called for the safe return of the girls; and

WHEREAS, the City of Wilmington has a long tradition of opposing human trafficking of any kind in the United States and the world; and

WHEREAS, these reprehensible actions necessitate a reaffirmed commitment to speaking out against human trafficking of all kinds.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the City of Wilmington extend its sympathies to the families of all children who have died as a result of the Boko Haram kidnappings.

**BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON** that the City of Wilmington extend its strong, unified and unwavering support to the kidnapping victims, their families and the people of Nigeria as they work for the return of the girls.

Ms. Shabazz: Mr. President, it lay heavy on my heart that I felt that I wanted to make sure everyone (inaudible) how the City of Wilmington's unwavering and unifying support of the victims and families of the people in Nigeria and how we - - as

we oppose the violent terrorist act against the young girls over there and I wanted to express it through this Resolution and look forward to my colleagues supporting it.

President Gregory: Ms. Dorsey Walker.

Ms. Dorsey Walker: Thank you Mr. President. If it is okay with the sponsor, I'd like to co-sponsor this Resolution with her.

Ms. Shabazz: I welcome everyone.

President Gregory: So noted, so noted.

Ms. Cabrera: I would like to be added as well Mr. President.

President Gregory: So noted. Mr. Prado.

Mr. Prado: Yes, I commend Councilwoman Shabazz for this Resolution. This is a terrible story – forced conversions of these young women and unfortunately in some of these tribal societies, if you are converted to Islam, you can't go back. They consider it apostasy. So, they'll be killed if they try to go back to their own religion. It's just a terrible story what's happened but I commend her for bringing this issue and I'm going to do something similar like – similar like this to what's going on in Syria. I think that we need to get a message to our delegation that there's a you know, a similar - similar terrible things are happening in Syria but unfortunately I think our government is on the wrong side of that conflict but I'll probably be doing something similar to this but I want to be a co-sponsor also too please.

President Gregory: Mr. Darius Brown.

Mr. D. Brown: Thank you Mr. President. We've seen a lot of coverage of this story around the 276 that were kidnapped - - a similar story that happened actually two weeks before this story – was forty-six young boys that were killed. A part of this culture is because of them being males they were killed and the females were kidnapped and very probable that they were sold into doing different things within the sex trade. So, I'd like to be added as a co-sponsor to this legislation but also want to bring some awareness to what is - what is occurring over there not only to young girls but also to young boys. So, even though it may be different culturally as to the impact there and what is occurring here in our country, we all should be mindful of – of – of these different occurrences that are happening around the world. And, I would just ask the sponsor that with – hopefully with passage of this - that this be also sent to our delegation and also to the Embassy of Nigeria.

President Gregory: So noted. Mr. Chukwuocha.

Mr. Chukwuocha: Thank you Mr. President. As well I would like to (inaudible) as co-sponsor. As many you know, I have deep family ties to Nigeria and I must say that one thing to me about this Resolution and a lot of people think that it happens, you know, that is mainly because of militancy and Islamic religion but there are many, many kidnapping in Nigeria that don't have anything to do with faith, they're just happening (inaudible) there's a lot of you know, ill will been happening. So, I'm glad that it is receiving a lot of attention but I think that some of the attention is being misskewed and misdirected to you know, this militancy Islam but there are kidnappings not only in Nigeria but throughout other countries throughout the continent of Africa. So, I just wanted to bring that point of awareness (inaudible). It was my family - - it was on Wednesday - on Tuesday we were at the soccer game Nigeria vs Greece and there was a great moment there where the Nigerian community stood up for the ladies. So, I'm definitely glad to be in support of this Resolution. Thank you.

President Gregory: So noted. Mr. Brown.

Mr. Michael Brown: I want to be added too Mr. President.

President Gregory: So noted. Clerk will call the roll.

Upon a motion of Ms. Shabazz, seconded by Mr. Williams, the above aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, D. Ms. Shabazz: I have a final - - an Ordinance to present and call for the first and second reading.

Ms. Shabazz presented and called for the first and second reading Ordinance No. 14-025 (Agenda #3938) entitled:

AN ORDINANCE TO AUTHORIZE AN AGREEMENT BETWEEN THE CITY AND THE KENT COUNTY SOCIETY FOR THE PREVENTION OF CRUELTY TO ANIMALS AK/A FIRST STATE ANIMAL CENTER AND SPCA FOR ANIMAL CONTROL SERVICES

This Ordinance was given two separate readings by title only and upon a motion of Ms. Shabazz, seconded by Mr. Freel, was received, recorded and referred to the Public Works & Transportation Committee. Motion prevailed.

President Gregory: I would encourage all of my colleagues to attend the meeting. Six hundred thousand dollars for an animal control and sheltering may seem like a nominally but that's what we're kind of stuck with. So, there's some new onsets that you really need to understand because what I don't want to do is have a committee meeting on the floor on the night that we vote on this. I mean some limited discussion but I really would not like to come here and have a full blown committee meeting. We can do it in committee. Mr. Prado.

Mr. Prado: No legislation Mr. President.

President Gregory: Ms. Dorsey Walker.

Ms. Dorsey Walker: Nothing tonight Mr. President. Thank you.

President Gregory: Mr. Williams.

Mr. Williams: No legislation this evening sir.

President Gregory: Mr. Freel.

Mr. Freel: Yes Mr. President. I have four Ordinances for third and final and one for first and second.

Mr. Freel: Yes Mr. President. We're entering into a new contract with PMA Management Corporation to process and administer our insurance claims program. The initial period is 14-months and then after that there's a potential for three one-year extensions. The initial period to 14-months is about \$114,500.00; the three extensions, if we enter into them, will be about \$98,150.00 a year.

President Gregory: Mr. Michael Brown.

Mr. M. Brown: Yes Mr. President. Nothing tonight, thank you for asking.

President Gregory: Ms. Cabrera.

Ms. Cabrera: Nothing this evening sir.

Mr. Wright: Yes Mr. President. I have an Ordinance to present.

Mr. Wright presented and called for the third and final reading <u>Ordinance</u> No. 14-005 (Agenda #3896) entitled:

This is not permitted in metered parking areas. The time variable that would be allowed is from 9am to 6pm. And again, this is not for metered areas and here we go.

President Gregory: Ms. Shabazz.

Ms. Shabazz: Thank you Mr. President. First, I want to commend Councilman Wright on this piece that's something that's really needed especially as Wilmington continues to evolve and grow that we do have to look at some of antiquated parking laws and come up with ways that we can make – doing business in the City much more feasible and I believe this is a very good piece and I would ask that I could be a cosponsor.

President Gregory: So noted. Ms. Cabrera.

Ms. Cabrera: I think that also this is an excellent piece and leads to you know providing that customer service and making sure that we are not so user unfriendly especially when it comes to businesses or that people would want to come and do business in the City of Wilmington. The only concern I have is that I believe the \$250 is still a steep amount but we're going to roll it out and see what happens and what kind of responds it needs and I'm sure we could always amend it down the road. I think

(inaudible) a business who has a multiple vehicles that have to come into the City to do work in different locations. You know it starts adding up into the thousands but this is an excellent piece and I commend Councilman Wright and I too would like to be a sponsor of it.
