### LEGISLATIVE BUSINESS

Council Member Gray presented Resolution No. 21-019 (Agenda #0043)

as follows:

**WHEREAS**, President Joseph R. Biden, Jr. proposed passage of the American Rescue Plan Act of 2021 to provide help to the many Americans who are suffering due to COVID-19; and

WHEREAS, on March 11, 2021, the President signed the American Rescue Plan Act of 2021, as amended, into law (the "Reconciliation Act"); and

WHEREAS, the Reconciliation Act includes the Coronavirus State and Local Fiscal Recovery Funds, which will provide \$350 billion in critical aid to state, local and territorial governments; and

WHEREAS, as cities continue to respond to the pandemic, we focus on effective governance - public health and economic recovery - over divisive politics. We are committed to working in a fashion to secure direct flexible funding for vulnerable

populations realizing they were the most impacted and to share the goal of keeping our residents healthy and our communities safe and vibrant; and

WHEREAS, the Reconciliation Act is estimated to provide approximately \$55 million to the City of Wilmington, based on the formula for allocation recently calculated by policy staff of National League of Cities; and

WHEREAS, the Reconciliation Act allows for funds to be used:

- 1. To respond to the pandemic or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- 2. For premium pay to eligible workers performing essential work (as determined by each recipient government) during the pandemic, providing up to \$13 per hour above regular wages;
- 3. For the provision of government services to the extent of the reduction in revenue due to the pandemic (relative to revenues collected in the most recent full fiscal year prior to the emergency); and
- 4. To make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, Wilmington will be eligible to receive these funds upon providing the U.S. Treasury with a certification on the use and need of the funds; and

WHEREAS, the social and economic impacts of COVID-19 have disproportionally impacted communities on the lower end of our economic scale, and despite good faith efforts, the delivery of funds under the CARES Act have demonstrated the challenge of having these resources reach many of our most impacted communities, leading to concerns about who has been left out; and

WHEREAS, the current deadline to expend the Coronavirus State and Local Fiscal Recovery Funds is December 31, 2024, thus allowing adequate time to thoughtfully develop a strategy to deliver these funds to communities most in need; and

WHEREAS, a thoughtful strategy will ensure that Wilmington has adequate funds to provide continued testing, vaccination, and other health-related programs needed to fight the ongoing pandemic, to restore costs incurred due to COVID-19, and to replace loss revenue resulting from City efforts and programs to provide needed tax relief to burdened citizens and loss of hotel tax revenue and other lost revenue streams; and

WHEREAS, a thoughtful strategy to allocate funds to communities most impacted could provide funds to significantly expand youth employment programs, housing programs, small business support, improvements in social service programs, increased broadband access, and many other needed actions that would mitigate against the current impacts of COVID-19 and build resiliency to strengthen the communities against future crises that disproportionally affect low-income communities; and

WHEREAS, Council Members are deeply involved in their communities and provide a strong voice to identify the specific needs of low-income communities, and should be a strong voice in the development of programs to strengthen these communities.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Council hereby intends to be an active participant in developing the City's strategy for the expenditure of any Coronavirus State and Local Fiscal Recovery Funds distributed to the City of Wilmington.

**BE IT FURTHER RESOLVED** that the Council will work with the Administration on the development and implementation of a comprehensive strategy for the most effective use of these funds and will carefully consider the needs of underserved communities that may be given significant relief through a bold strategy associated with this unique funding opportunity.

**BE IT FURTHER RESOLVED** that the Council also expressly intends that discretionary decision-making of funding allocations from the Coronavirus State and Local Fiscal Recovery Funds, beyond reimbursement of lost City revenue and direct costs of the fight against COVID-19, be considered through a lens of advancing equity and social justice throughout Wilmington.

**BE IT FURTHER RESOLVED** that the Council shall also require that the allocation of funds from the Coronavirus State and Local Fiscal Recovery Funds shall be pursuant to legislative action by Council, a co-equal branch of City Government with the Administration, before any expenditure and that each legislative appropriation include a clear description of how the funds will be expended.

Upon a motion of Council Member Gray, seconded by Council Member Walsh, the Resolution was before the Council for its consideration. Council Member Gray spoke on the purpose of the Resolution and made comments. President Congo requested to be added as a co-sponsor. Council Member Harlee made additional comments. President Congo made comments. Council Member Darby made additional comments. Council Member Gray made final comments.

President Congo requested the Clerk to call for the roll.

The above-referenced Resolution was received, **adopted** as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Gray, Darby, Oliver, Harlee, B. Fields, McCoy, Johnson, N. Field, Cabrera, Dixon and Spadola, and Council President Congo. Total, twelve. Nays, Council Member Walsh. Total, one.

President Congo declared the Resolution adopted.

Council Member Darby presented and called for the first and second reading Ordinance No. 21-021 (Agenda #0034) entitled:

AN ORDINANCE TO AMEND CHAPTER 4 OF THE CITY CODE TO PROVIDE FOR CIVIL FINES FOR OWNERS OF VACANT PROPERTIES WHO FAIL TO REGISTER THEM

The above-referenced Ordinance was given two separate readings by title only and upon a motion of Council Member Darby, seconded by Council Member Walsh, the Ordinance was received, recorded, and referred to the Community Development & Urban Planning Committee. Motion prevailed.

Council Member Darby presented <u>Resolution No. 21-020</u> (Agenda #0044) as follows:

WHEREAS, 30 Del. Code §2101 provides that no person shall engage in or carry on any trade or business for which a license is required without first having obtained a license from the Department of Finance; and

WHEREAS, Black's Law Dictionary defines "business" as, "A commercial enterprise carried on for profit; a particular occupation or employment habitually engaged in for livelihood or gain; and

WHEREAS, Part III of Title 30 of the Delaware Code ("Part III") goes on to include licensing requirements for contractors, manufacturers, retail and wholesale merchants, and persons engaged in specific occupations including, among many, commercial lessors and tourist home operators; and

WHEREAS, neither Part III nor any other provision of the Delaware Code require lessors of residential properties to obtain a business license; and

WHEREAS, therefore, Delaware residential landlords receive the full benefits of operating as a business without adhering to the standards and authority of applicable Delaware law; and

WHEREAS, currently the City of Wilmington requires all landlords to obtain and maintain a Residential Property Rental License annually and also requires all rental properties to be registered and receive interior and exterior inspections; and

WHEREAS, the Wilmington City Council believes it is necessary and proper to require Delaware landlords of residential property to obtain and maintain a valid business license; and

WHEREAS, currently under Delaware state law, failure of anyone to carry on without a license, any occupation or business for which a license is required, makes them liable for the payment of license fees and a fine of up to \$3,000, or imprisonment not more than two years, or both; and

WHEREAS, landlords in Delaware are not currently subjected to such requirements or enforcement; and

WHEREAS, a landlord's noncompliance with state law can potentially harm the physical, mental and emotional well-being of Delaware renters and the State's interest in decreasing homelessness; and

WHEREAS, the Wilmington City Council believes that landlords should be held to the same standards as all Delaware business owners, and landlords who seek remedy under the law should first be required to show that they have been compliant with the law; and

WHEREAS, Delaware legal aid organizations, researchers and housing advocates have argued, and the Wilmington City Council agrees, that the ease with which Delaware landlords can evict tenants contributes to Delaware's high eviction rates and homelessness statewide; and

WHEREAS, the Princeton Eviction Lab—responsible for the first ever nationwide eviction data sets on evictions for the years 2000 to 2016—found Delaware's 2016 eviction rate was 5.1%, averaging approximately 14 evictions per day, while the 2016 national average was approximately 3%; and

WHEREAS, the Biden School of Public Policy & Administration Center for Community Research & Service examined a sample of 300 eviction cases from Delaware's Justice of the Peace Court #13, Delaware's busiest eviction court, and found that 82% of the eviction hearings held resulted in landlords receiving a possession judgment to evict, 72% of which were by default; and

WHEREAS, nearby jurisdictions including Philadelphia, PA, Washington D.C., Baltimore County, Maryland, Anne Arundel County, Maryland, and Ocean City, Maryland have recognized the complexity of the residential rental business in that it is not merely a source of income for investor-owners but also a source of habitable, stable housing for their residents; and

WHEREAS, the aforementioned jurisdictions have enacted laws which prevent a landlord from filing an eviction action or having an eviction or other default or consent judgment entered against a tenant if the landlord did not have a valid business license during the entire relevant period or does not possess a valid business license at the time of filing a complaint; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington City Council urges the Delaware General Assembly to enact legislation mandating that all Delaware landlords maintain a valid business license and prohibiting landlords operating in Delaware without a valid business license from filing an eviction action or having a judgment entered against a tenant.

WHEREAS, Chapter 90, Title 11 of Delaware Code has not been updated to reflect the increased costs of funeral and burial, since its inception; and

**WHEREAS**, Wilmington residents who are secondary victims of crime as defined by Chapter 90, Title 11 of Delaware Code have experienced additional burden in recent years; and

WHEREAS, current rules restrict access to VCAP funds for the commission of a crime, that is often unrelated to the victim's reasons for applying for VCAP funds and contributes to the financial burden of the victim; and

WHEREAS, the current amount of funeral and burial assistance is no more than \$5,000 total; and

**WHEREAS**, the average cost of funeral and burial are levied between \$7,000 and \$12,000 which is difficult for many low-income families to afford.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Delaware General Assembly is urged to

increase amount of Victims' Compensation Assistance Programs funeral allotment to \$5,000 and burial allotment to \$2,500 for a total of \$7,500.

WHEREAS, 83% of youth e-cigarette smokers use flavored products, with 70% reporting they use e-cigarettes specifically because of the flavor; and

WHEREAS, the U.S. Food and Drug Administration has concluded that e-cigarettes lead to increased smoking initiation among young adults and decreased success in quitting smoking, and

WHEREAS, conclusive evidence demonstrates that the use of tobacco products increases the risk for respiratory infections, weakens the immune system, and is a major cause of a number of chronic health conditions, including multiple lung diseases, heart disease, and cancer, and

WHEREAS, it is documented that people who utilize tobacco products are at greater risk for becoming addicted and suffer chronic lung disease that can compromise the ability to fulfill daily functions and lead to terminal illness, and

WHEREAS, the tobacco industry initially and inaccurately marketed ecigarettes as safer and healthier cigarettes which led to increased initiation; and

**WHEREAS**, the COVID-19 pandemic has placed increased attention on lung health; and

**WHEREAS**, smoking increases the risk of the most severe impacts of COVID-19, preventing and reducing tobacco use is critical; and

WHEREAS, parents, schools, students and public health organizations, including the Centers for Disease Control, American Cancer Society Cancer Action Network, American Lung Association, American Heart Association, the Campaign for Tobacco-Free Kids, Delaware State Conference of the NAACP, and Metropolitan Wilmington Urban League support prohibiting the sale of all flavored tobacco products.

**BE IT THERFORE RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON** that this legislative body implores the State of Delaware to support Representative Melissa Minor-Brown in her efforts to end the sale of flavored tobacco products in the State of Delaware. This would protect Delaware communities and specifically communities of color from the harms of flavored tobacco and reduce the ever increasing tobacco experimentation by youth that perpetuates the cycle of addiction in impoverished communities of color.
