An Ordinance to Amend Chapter 40 of the City Code to Establish 22 Del. C. § 841's Five-Year Maximum Residency Period Requirement and Establishes the Geographical Boundaries Within the City of Wilmington Limits, and to Establish a Residency Working Group **(1<sup>st</sup> & 2<sup>nd</sup> Reading)**

**Synopsis:** *This Ordinance is being presented by City Council for Council's review and approval. This Ordinance amends Chapter 40 of the City Code to establish a Five-Year residency requirement for city employees, excluding elected officials, and establishes the geographical boundaries within the City of Wilmington limits. Also, this Ordinance establishes a Residency Working Group. Lastly, on a housekeeping note, this Ordinance updates the names of the Human Resources Department and its Director.*
